

VERIFIED PETITION FOR DISSOLUTION OF MARRIAGE

COMES NOW, the Petitioner, Kathleen Marie Fogle ("Wife"), and files her *Verified Petition for Dissolution of Marriage*, and in support of her Petition, respectfully shows the Court as follows:

1. Wife has been a continuous and bona fide resident of the State of Indiana for a period of six (6) months and a bona fide resident of the County of Boone for a period of three (3) months prior to the date of the filing of this Petition, as has the Respondent, Jared Fogle.

2. The parties were married on July 31, 2010.

3. The parties were separated according to statute on the date of the filing of this *Verified Petition for Dissolution of Marriage*.


WHEREFORE, the Petitioner, Kathleen Marie Fogle, respectfully requests:
