1 IT IS FURTHER ORDERED, ADJUDGED AND DECREED:

2 A. The court finds that the parties have entered into a Marital Settlement  
3 Agreement (hereinafter referred to as MSA) that addresses all issues in this  
4 proceeding, including but not limited to: child custody and support, spousal support,  
5 division of community property and confirmation of separate property.

6 1. The parties, jointly, shall be awarded legal and physical custody of the  
7 minor children pursuant to the MSA.

8 2. Both parties are capable of supporting the minor children. At this  
9 time no child support shall be ordered and the court shall reserve jurisdiction over child  
10 support.

11 3. Both parties are fully self-supporting, each waives all right or claim  
12 which he or she may now or may at any future time have to receive support from the  
13 other. The court's jurisdiction to award spousal support to either party is hereby  
14 terminated.

15 B. The court further finds that the parties have agreed not to file said MSA  
16 with the Court at this time. Nonetheless, the parties agree that the MSA shall be fully  
17 enforceable between the parties. Further, should either party seek relief from the Court  
18 in order to enforce or modify the MSA or file any post judgment motions, they may file  
19 this MSA with the Court and the Court shall enforce the terms of the MSA pursuant to  
20 California Code of Civil Procedure section 664.6:

21 664.6. If parties to pending litigation stipulate, in writing signed by the parties outside the presence  
22 of the court or orally before the court, for settlement of the case, or part thereof, the court, upon  
23 motion, may enter judgment pursuant to the terms of the settlement. If requested by the parties,  
the court may retain jurisdiction over the parties to enforce the settlement until performance in full  
of the terms of the settlement.


24 C. The court shall reserve jurisdiction to make whatever orders may be

26 the parties any community assets or liabilities omitted from division under said MSA.

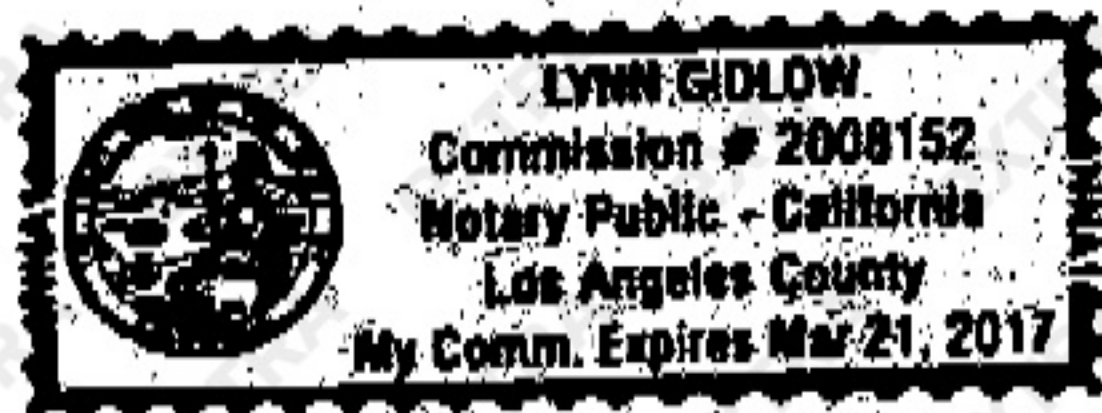
